The information below is intended to help you with your membership application.

Please note: all fees and charges are subject to change without notice

- To apply, mail to the Membership Director the completed Membership Application with a cheque payable to Hawkestone Yacht Club in the amount of \$200.00 + HST=\$226.00. This will form part of the Initiation Fee of \$2085 plus HST. The initiation fee is non-refundable. Upon acceptance as a member, there is a Membership Certificate fee of \$2085 plus HST. The Membership Certificate fee is non-refundable. Arrangements may be made with the HYC Treasurer to pay The Membership Certificate Fee on a deferment plan within the first year with an added administration fee. There is also an annual membership fee of \$270 plus HST which is not pro-rated and is non-refundable. If accepted and you choose to pay the entire amount up front, the total cost would be \$5,017.20 The required fees are due within 30 days of notice of acceptance, non-payment will void the application.

- Your membership application will be reviewed at the first Board meeting following receipt of your application. If your membership application is accepted, the submitted cheque will be cashed and you will be notified of your membership at Hawkestone Yacht Club. The HYC Treasurer would send you a billing for the balances due.
- Upon availability of space in our harbour, you will be billed for:
 - Slip Fee @\$46 per foot of boat length (pro-rated based on full or part months remaining in the sailing season for applicants accepted after the beginning of the season) Winter storage is included in the slip fee.
 - Lift-In Fee (if applicable) @ \$125 for boats under 27', \$135 for boats 28' to 30' inclusive, and \$145 for boats over 30'
 - Fall Lift-Out Fee (if applicable) is at same rate as Lift-In.

If your membership application is not accepted, the submitted cheque will be returned to you.

Prior to lift-in or arrival of your boat at HYC, you will be required to present proof of insurance to the Harbourmaster.

After a full year at Hawkestone Yacht Club your membership will be reviewed by The Board of Directors.

Continued membership requires

- Prompt payment of all dues, fees and levies
- Full completion of work hours or payment of work hours fees
- Compliance with the rules and regulations of the club
- Active participation in club activities and events
